Mr. Johnson reported that the Gravel Doctor has purchased a gravel pit in Conmee Township. The access to this pit is from Strom Road in the Township of O'Connor. Mr. Johnson currently has a half load agreement signed with them and he continues to monitor the condition of the road. Due to the amount of gravel that will be removed from this pit in the future and the number of trucks that will travel on Strom road, a permanent agreement with the Gravel Doctor was discussed. Mr. Johnson will speak with the owners to negotiate an agreement and the Clerk-Treasurer will draft up a formal agreement and bring it back for Council's approval. Sample agreements from neighbouring municipalities were reviewed and will be used to help create this document.

The Ministry of Natural Resources has in 2008 introduced royalties for gravel pits within a municipality. These monies will be given to the municipality in which the gravel pit is located. Due to the location of this pit and the use of the Township of O'Connor roads to access this pit, Council would like the Clerk-Treasurer to contact the Township of Conmee to see if an agreement could be negotiated to share these royalties with the Township of O'Connor.

- d) Cutting of Weeds on the sides of the Township roads was discussed. Council would like a request for quotes to go out in the June cornerstone with quotes to be in June 9, 2008 at 4 p.m.
- e) Ministry of Municipal Affairs and Housing regarding Municipal Boundaries. The Township of O'Connor currently does not have GIS mapping for our township. Council would like the Ministry to come out to the township to confirming their mapping coordinates.
- f) Stewardship Ontario – a letter regarding Municipal Hazardous or Special Waste Shared Responsibility Agreement and a Municipal Hazardous or Special Waste Program Plan Addendum was discussed. A memo from Deputy Clerk-Treasurer regarding this information and her conversation with Brian Friesen, P. Eng. of Stewardship Ontario was read. Council would like the Clerk-Treasurer to contact the surrounding municipalities to see if they are interested in participating in this program. The Township will not sign an individual agreement.

Issues brought forward or letters received after the agenda was mailed.

WHEREAS THE ONTARIO'S CROWN FOREST SUSTAINABILITY ACT (CFSA):

- **HAS BEEN IN PLACE SINCE 1994 AND REQUIRES "THAT FOREST MANAGEMENT PLANS (FMPS) IDENTIFY THREATENED AND ENDANGERED SPECIES AS "FEATURED SPECIES" AND PROVIDE FOR THEIR PROTECTION WITHIN THE AREA COVERED BY THE PLAN,"**
- **IS BUILT ON A MODEL OF CONTINUOUS IMPROVEMENT AND ADAPTIVE MANAGEMENT,**
- **FOREST MANAGEMENT GUIDES/GUIDELINES MUST BE REVIEWED AT A MINIMUM OF EVERY 5-YEARS TO ENSURE THEY INCORPORATE AND REFLECT NEW SCIENCE, AND**

WHEREAS THE IMPLEMENTATION OF CFSA HAS RESULTED IN A PROVEN, EFFECTIVE AND EFFICIENT MEANS OF PROVIDING FOR SPECIES AT RISK, AND

WHEREAS ONTARIO'S FORESTRY PRACTICES THAT ARE INTERNATIONALLY RECOGNIZED AS WORLD CLASS.

THEREFORE BE IT RESOLVED THAT THE CORPORATION OF THE TOWNSHIP OF O'CONNOR

A) CALLS ON THE GOVERNMENT OF ONTARIO TO ENSURE THAT THE "ENDANGERED SPECIES ACT (ESA) WILL NOT REPLACE THE FOREST MANAGEMENT PLANNING PROCESS, BUT RATHER COMPLEMENTS THIS PROCESS AND PROVIDE OPPORTUNITIES TO INTEGRATE SPECIES AND HABITAT PROTECTION REQUIREMENTS", AND

B) CALLS ON THE GOVERNMENT OF ONTARIO TO LIVE UP TO THE COMMITMENT MADE BY THE MINISTER OF NATURAL RESOURCES IN MAY, 2007 WHEN HE STATED "SPECIFIC RECOGNITION OF THE CROWN FOREST SUSTAINABILITY ACT (CFSA) AND FOREST

MANAGEMENT PLANS AS EQUIVALENT PROCESSES WHICH PLAN FOR SPECIES AT RISK (AND) CAN BE ACCOMPLISHED THROUGH BILL 184 (THE ENDANGERED SPECIES ACT). SPECIFICALLY, SECTION 54 (NOW SECTION 55) ALLOWS REGULATIONS TO BE MADE WHICH CAN PROVIDE FOR FOREST MANAGEMENT ACTIVITIES THAT ADDRESS PROTECTION OF SPECIES AT RISK AND THEIR HABITAT”

C) AND THAT THIS RESOLUTION BE IMMEDIATELY FAXED TO THE FOLLOWING: PREMIER OF ONTARIO, MINISTER OF NATURAL RESOURCES, MINISTER OF NORTHERN DEVELOPMENT AND MINES, THE ONTARIO CABINET, LEADER OF THE OPPOSITION, LEADER OF THE NEW DEMOCRATIC PARTY, AREA MPPS, NOMA, NOACC.
