Mr. Johnson was asked if he wished to address Council on any personal matters and he replied yes. Mr. Johnson asked Council if they have done anything with regard to concerns of Premier Wynne and the Province selling off a portion of Hydro One. Council informed Mr. Johnson that they have endorsed a resolution at their April meeting and it has been forwarded to the Premier.

Mr. Johnson, Leadhand was welcomed to the table. The Monthly Road Department report from April 11 to May 8, 2015 was read. An inquiry was made with regard to the recent ruts and spin marks in the municipal yard. It was suggested that security cameras be placed around the community centre to try and discourage the people from causing this damage and before the building or windows get damaged from flying rocks. Signage would also be posted informing those in the yard of these cameras. This will be discussed further at the budget meeting.

Roadwork in general was discussed. Mr. Johnson informed Council that Ms. Earl will be starting back to work this week. They have been grading roads, power washing equipment and will be starting on changing culverts soon. The brushing project is complete at this time.

Additional attendees will be discussed at the budget meeting. At this time no deputations will be requested from the Township of O'Connor.
- e) Minister Responsible for Seniors Affairs regarding 2015 Seniors' Month celebrations. Information will be included in the June Cornerstone.

The balance of the correspondence was passed around the table.

Under Old business, Council discussed

a) Lakehead Region Conservation Authority (LRCA) - regarding Plan Input and Review of the LRCA's Regulatory Role – the summary of the presentation provided by the LRCA from the meeting that Council will be unable to attend was read for information purposes.

With regard to the LRCA - Hazelwood area and the information currently in the news with regard to the dismantling of the building, Councillor Vezina, as the LRCA Board representative for the Township, gave an update on the issue.

b) The next steps for the Township of O'Connor's Official Plan review were discussed. The Clerk-Treasurer reported that according to the Ministry of Municipal Affairs and Housing, there are a few other municipalities in the area that are also due for a review. If these municipalities would be interested in doing a review at the same time the Township could possibly use the same consultant and share the travel costs if someone is selected from out of the area. It was agreed that the Township will request this item be added to the upcoming Lakehead Rural Municipal Committee meeting to be held on May 14 for discussion.

Under New Business, Council discussed

a) Municipality of Oliver Paipoonge – regarding the venue for the Thunder Bay District Municipal League Conferences. The Municipality has a concern that the meeting room used is not conducive for this type of conference. Councillor Loan informed Council that this issue was already discussed by the Board at their meeting on May 9 and the Board has dealt with it. A price comparison for the possible venues was reviewed and Council agreed that the Conference should remain at its current location with a possible different setup.

Councillor Racicot left the room.

b) Linda Braun, Ministry of Northern Development and Mines regarding the Rural Ontario Institute – invitation to participate in a Developing the Ontario Rural Knowledge Network session to be held in Thunder Bay on June 22, 2015. It was agreed that no one will attend.

Councillor Racicot returned to the room.

- c) Lakehead Region Conservation Authority Invitation to participate in webinar at the LRCA office with regard to flooding and green infrastructure. Council were not interested in attending but as the webinar is during the day and if Mr. Johnson was interested in attending Council had no problem with his participation.
- d) Wolters Kluwer regarding The Manual for Elected Municipal Officials Ontario. The manual is practical and comprehensive and contains information on day to day functions of a Councillor in Ontario. It was agreed to order one copy of the book at this time.
- e) Andrea Horwath, Leader of the Ontario's New Democrats regarding Privatizing Hydro One. This information will be put into the June issue of the Cornerstone for the Township residents to respond to if they wish.

f) Ministry of Citizenship, Immigration and International Trade – regarding the Ontario Medal for Good Citizenship. No nominations will be submitted.

Issues brought forward or letters received after the agenda was mailed were discussed as follows:

a) An email was read from Maureen Mills, Senior Special Event Officer from the Thunder Bay Regional Health Sciences Foundation with regard to the upcoming Motorcycle Ride for Dad. They would like to use the Community Centre yard as a lunch pit stop for their riders. The event will be held on June 20, 2015 and they would be in the area between 11 a.m. and 1 p.m.. Council agreed to allow them to use the municipal yard but suggested that they may want to have a second portapottie brought in if they get a large turnout. The Clerk-Treasurer will contact Ms. Mills and coordinate the use.

For information purposes a building permit was approved for an addition at 117 Pool Road.
