Minutes of the meeting held on October 26, 2009 at 7 p.m. in the municipal building.

Fire Chief Mattas was welcomed to the table. The Fire Department Report was reviewed. There have been three first response related call between September 25th and October 25th. The Ontario Power Generation test call, which was implemented on Friday, October 23, 2009 was discussed. The Fire Department did receive the text page. The Municipal office staff were unavailable to receive the call since the office is closed at noon on Fridays and efforts to reach staff and the roads department by the Lakehead Region Conservation Authority were unsuccessful.

Kevin Schooler of the Ontario Fire Marshall's office was contacted by Fire Chief Mattas regarding procedure for disciplinary action for department member. The Township does currently have a policy in place, however the Fire Chief Mattas will review this policy and it will be brought to Council for any needed amendments.

The issue of Fire Department and 1st Response member receiving a stipend for training sessions that are attended was discussed. It was noted that members are paid for any Ontario Fire College training courses that they attend, however they are not paid for any other training courses that they attend including 1st response training. Council would like the policy brought to the next meeting of Council for review.

On November 30th a training session with Officer Doug Goulding and Officer Todd Smith of the Ontario Provincial Police will be held at the O'Connor Municipal Building. The training will involve note taking and how to handle an accident scene. Other surrounding departments will be invited to attend. The department will supply refreshments.

An update on the tire repair for the pumper was discussed. A used tire for the pumper truck will be purchased from Kevin's Tire Service and installed within the next week. It was noted that this issue was also brought up during the Township Inspection held on October 24, 2009.

The air compressor for filling the department member's oxygen tanks was discussed. Chief Mattas has ordered a new compressor from Superior Safety and it should be arriving soon. Payment for the compressor can be made in two installments with the second installment due in 2010. An advertisement will be placed in the next issue of

the Cornerstone and on Kijji to sell the old compressor, which failed due to the dew point level. Asking price for the compressor will be \$2,500.00.

Fire Chief Mattas was thanked for attending the meeting.

Staff Sergeant Larry Lamme was welcomed to the table and introductions were made. Staff Sergeant Lamme has been Acting Detachment Commander since September of this year and commented that the position should be filled by January of 2010.

Staff Sergeant Lamme commented on the low crime rate in the Township of O'Connor. Councillor Garbutt commented on a recent call made by the Clerk-Treasurer regarding the theft of batteries out of the compactor at the Disposal Site and that the detachments response was not acceptable.

Staff Sergeant Lamme commented on the Township's Emergency Plan that had not been updated recently. An updated call out list was given to Staff Sergeant Lamme.

Councillor Garbutt inquired as to why there has not been a Community Policing Advisory Committee meeting recently. Staff Sergeant Lamme will look into setting up a meeting with committee members.

An invitation to O'Connor Day 2010 was extended to Staff Sergeant Lamme and he was thanked for attending the meeting.

Councillor Garbutt brought up the issue of hall rentals for the O'Connor Community Club and the O'Connor Volunteer Fire Department Auxiliary. The policy for hall rental fees will be reviewed at the next meeting of Council.

The issue of dogs running at large was discussed. There have been a number of complaints received regarding dogs. Council would like changes made to the policy regarding dog and the fees charged to the owners for finding them running at large. Council would like the policy changed to reflect a first time offence of a warning and return of the dog, a second time offence of a fine and return of the dog once the fine is paid and a third time offence of an increased fine and the dog being brought into the Thunder Bay Animal Services. This policy will be brought to the next Council meeting.
